- The St. Thomas Mar Thoma Church, Kozhencherry started a Pre-Primary school in 1982 named as Mar Thoma English Medium School.
- The School applied for CBSE affiliation and got inspected 28-12-1994 and subsequently got affiliation for senior secondary examinations.
- The initial affiliation got for 3 years w.e.f. 01-04-1995 to 31-03-1998.
- Since 16-04-1998 the school has been named as Mar Thoma Senior Secondary School Kozhencherry (copy of the CBSE, Delhi attached).
- Due to the 2018 flood, the school was fully flooded and affected. All the old files were irrecoverably lost. (certificate to this effect is enclosed).
